2008 AutoCross Series:

New Business:

This would be about \$1600.00 The programming change is extra and carrying cases are not included. **Motion:** To purchase the hand-held radios units from Perl Benner for \$1600.00. (Drew/George). Passed unanimous.

George asked how if we got a truck for the trailer. Bill said that he needed the plates from George to bring the truck over.

Drew has historical boxes dating back to 1958 – He would like to put together a display of the dash plagues that came from Dave Banks' estate.

Motion: If there is no other business to come before the Board, meeting was adjourned by Howard Roundy at 8:13 pm (Bill/Gary).
