- -Students can be passengers in the instructor's car, with the instructor's permission, however the run will be timed as normal.
- -In an instance where the student wishes to have the instructor drive them and the instructor agrees but is unable to accommodate because they lack a passenger seat in their vehicle, or some other valid reason, the instructor can be granted permission to use the students' car from the chair of the event or the next in charge if the chair is unavailable. The run will be an untimed, 'instructor run', and will only be allowed once per instructor per event.

This ruling will take effect immediately until further notice.
