

# Sports Car Club New Hampshire Minutes of the Annual Business Meeting Friday, November 21, 2008

SCCNH President Howard Roundy called the Annual Business Meeting to order at 7:21 pm.

**Secretary's Report**: Donna Stevens distributed the minutes from the October meeting. **Motion:** To accept the Secretary's minutes from the October meeting. (Gary/Bill)

**Treasurer's Report**: George gave the Treasurer's report. The two Hobo-day event took in \$3725.83. Expenses were \$2555.73 for a profit of \$1169.10. Most of the credit card income has been deposited leaving a balance of \$21.03 in the PayPal account. As of October 30<sup>th</sup> the SCCNH Money Market has \$4,952.07, PayPals - \$21.03, the Regular checking account \$10,549.67 and the PayPals checking account \$815.77 for a total of \$16,338.54.

**Motion:** To accept the Treasurer's report (Bill/Matt)

**Membership Report**: SCCNH has 114 members with 13 Life members. For 2009 we are at 17 with 13 Life members. (See agenda item under New Business regarding the membership dues for 2009)

at the Hobo Train Station in Lincoln NH. Saturday was challenging, to say the least. It was raining most of the day and there was little traction. We had 48 participants. Sunday was colder however, the pavement dried up as the day went on. We had 12 teams. We had three additional teams that wanted to register after Registration closed but we could only take 12. A DNF was given for not coming to a complete stop in the Stop box or running past the line of end cones – this added 40 seconds to the time. Everything went great, the park was happy, we made money. Reaction from the teams was they really enjoyed the day. We sent the Clarks a thank you note. The plan is to hold the Hobo event there again next Fall, but not the Spring event (due to the 8' snow bank blocking the entrance this year). Fortunately the Young brothers took care of the trailer to and from the event. **THANK YOU George and Drew!!** Anyone who brings the trailer to and from the event for next year will receive a free AutoX entry. Bill will present the 2009 AutoX schedule at the

January meeting. Gary asked about the trailer if anything needs to be done. It still needs a seam and the tarp has to be put on.

#### **Old Business:**

Matt says that his personal server will be up and running mid-January and he would offer his server for the SCCNH club. SCCNH.org has to change its IP address.

**Bylaws:** Howard asked if there are any changes or objections to the amendments of the Bylaws that were proposed. Bill questioned when the monthly meeting should be – Howard read from the Bylaws that it would be set at the Annual meeting (which is today).

**Motion:** To accept and post the Bylaws amendments that were proposed. (Bill/Dave) Passed
