**Treasurer's Report**: George Young presented the Treasurers' report. In the past month we paid for Mt. Ascutney, the brass life membership plaques and the Venne retirement gift. Currently we have \$1,267.62 in PayPals; Regular checking account \$5,132.94 and \$4,704.65 in the Money Market account for a total of \$11,105.21. Checks for the remainder of Sunday's autocross and the deposit for next month's events were cut for NHMS. **Motion to accept the treasurer's report was made by Drew Young and seconded by Bill Bennert, passed.** 

Howard received a nice note from Judy Fry thanking the Club for her Lifetime membership plaque and she made a contribution of \$150.00 to the Club – Thank you Judy!

**Membership Report**: Dan reported that we currently have 66 SCCNH members including 15 Lifetime members. Membership forms will be available at the AutoCross and the Hillclimb event.

## **Programs and Events:**

**SCCNH AutoCross Report:** There will be an event on this Sunday which is Mother's Day. We will be cleaning the trailer at Drew's place on Saturday afternoon. Howard will prepare the 'list' of people who are setting up on Sunday morning; they can get in at 7:30 and the rest of them will be allowed in at 8:00 am. There are 41 people pre-registered as of this meeting. The new track rules will be printed and posted. Fun runs will be done at the end of each event if time permits – fun runs are \$2.00 each. George has been working all day with K&K to get the insurance straightened out for Sunday's event. Plaques will be late for this event.

Donations will be accepted for the Concord Community Action Area Center Food Pantry at the AutoCross event. Points towards the Dave Erb trophy will be credited to those who bring food donations.

#### Mt. Ascutney Hillclimb Report:

Drew is working on the Hillclimb trailer. Drew has all the paperwork ready for the Hillclimb. Fire extinguishers will be Monday. Three or four of them will have to be replaced. The certification,

refill and replacement is expected to be approximately \$800. Wire crew is all set. The long course was discussed but we do not have enough equipment to do the long course at this time. Drew received a notice from the State of Vermont to comment on a proposed 50% increase in the fee. Drew is going to submit a rebuttal. George was instructed to send a check for the permit for September immediately.

There are 22 pre-registered entries for next weeks hillclimb at this time. Deadline to get the early entry fee is Wednesday. The online registration site will be closed on Wednesday. Workers lunch is pizza on Saturday and finger rolls on Sunday. Valve cover racing will be on Saturday night. Dave has ordered all the trophies. Food pantry donation will be accepted and given to a local area charity earning the donating member Dave Erb trophy points.

#### **Old Business:**

**Incorporation Process** – Howard officially has the paperwork and we are back in sync with the State.

George Young & Paul Giblin presented a retirement card and check to Jerry & Linda Venne on behalf of the SCCNH membership on Saturday, May 2, 2009 - the card & check were well-received and Jerry & Linda were extremely appreciative.
